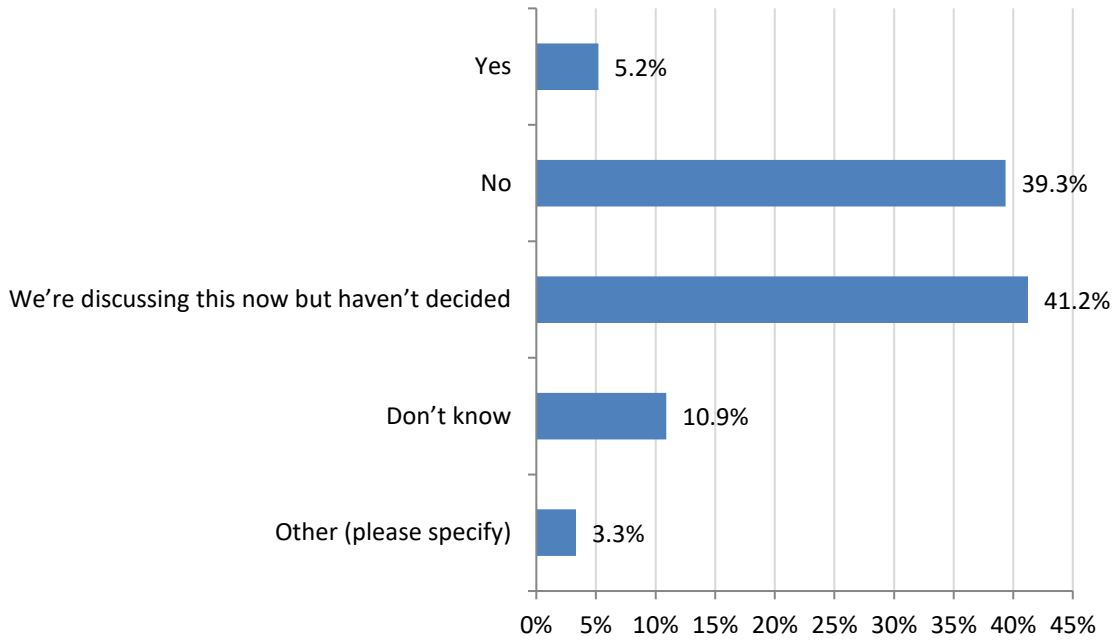

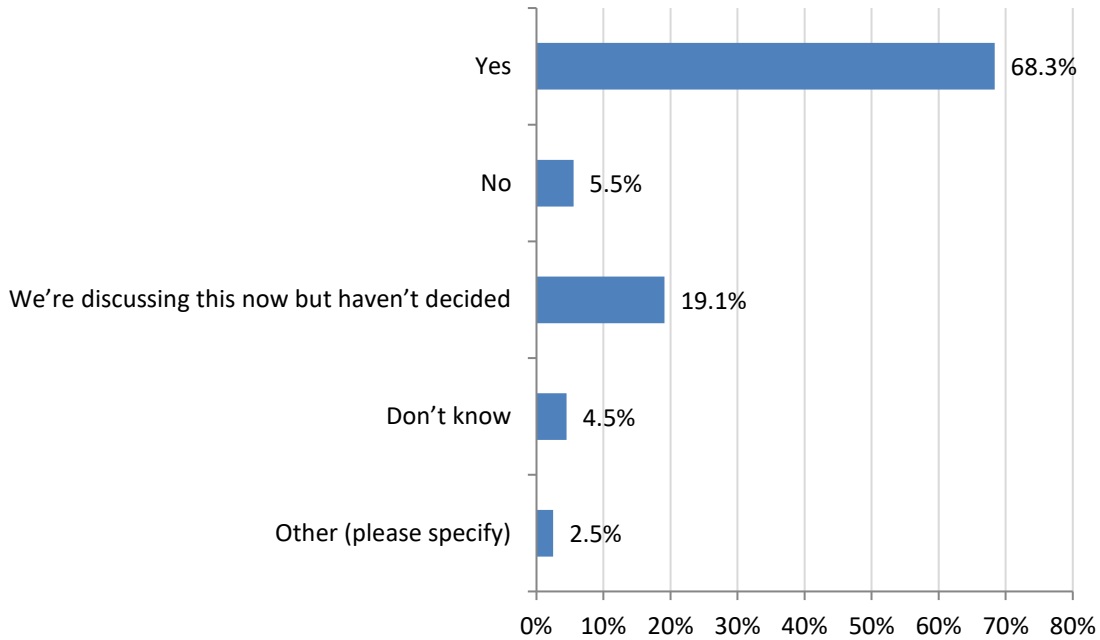

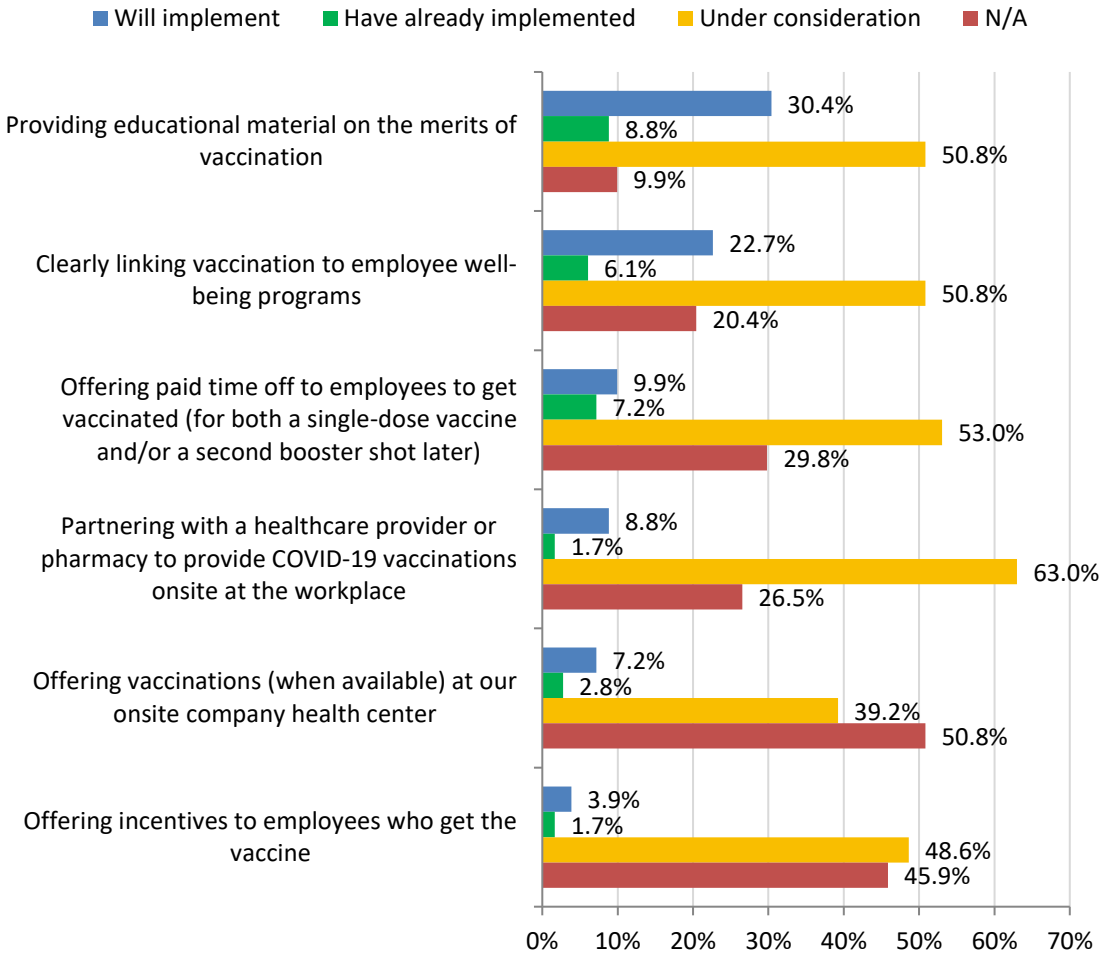

2. Does your organization plan to encourage its employees to receive a COVID-19 vaccine once they become widely available to the public?



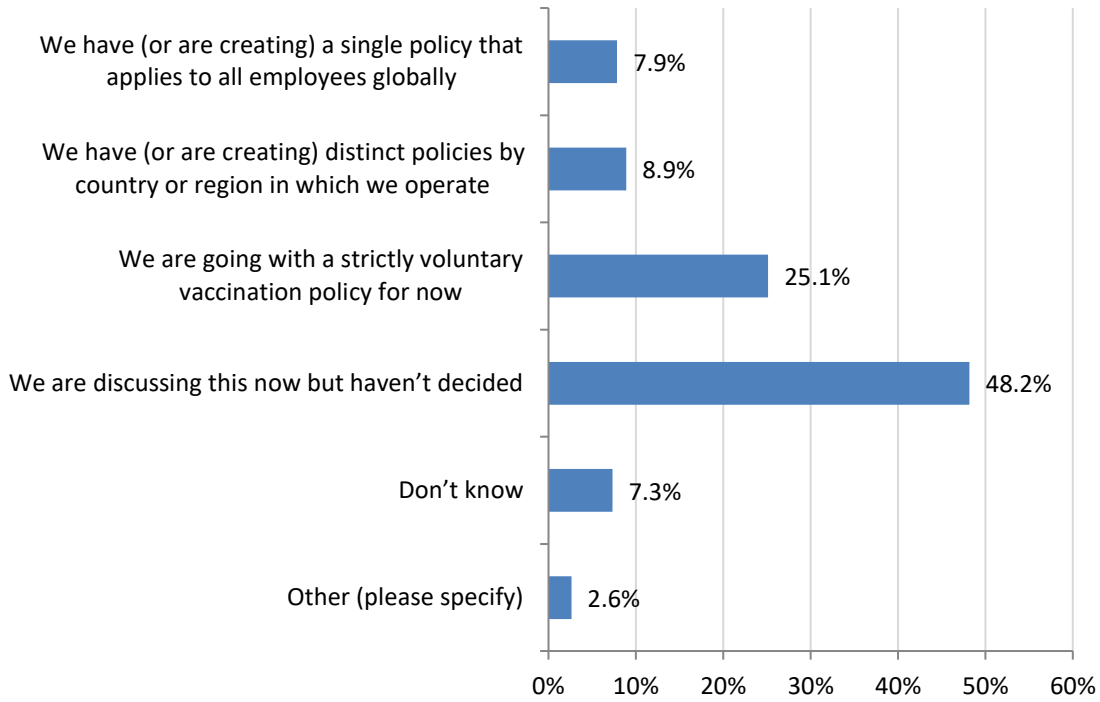

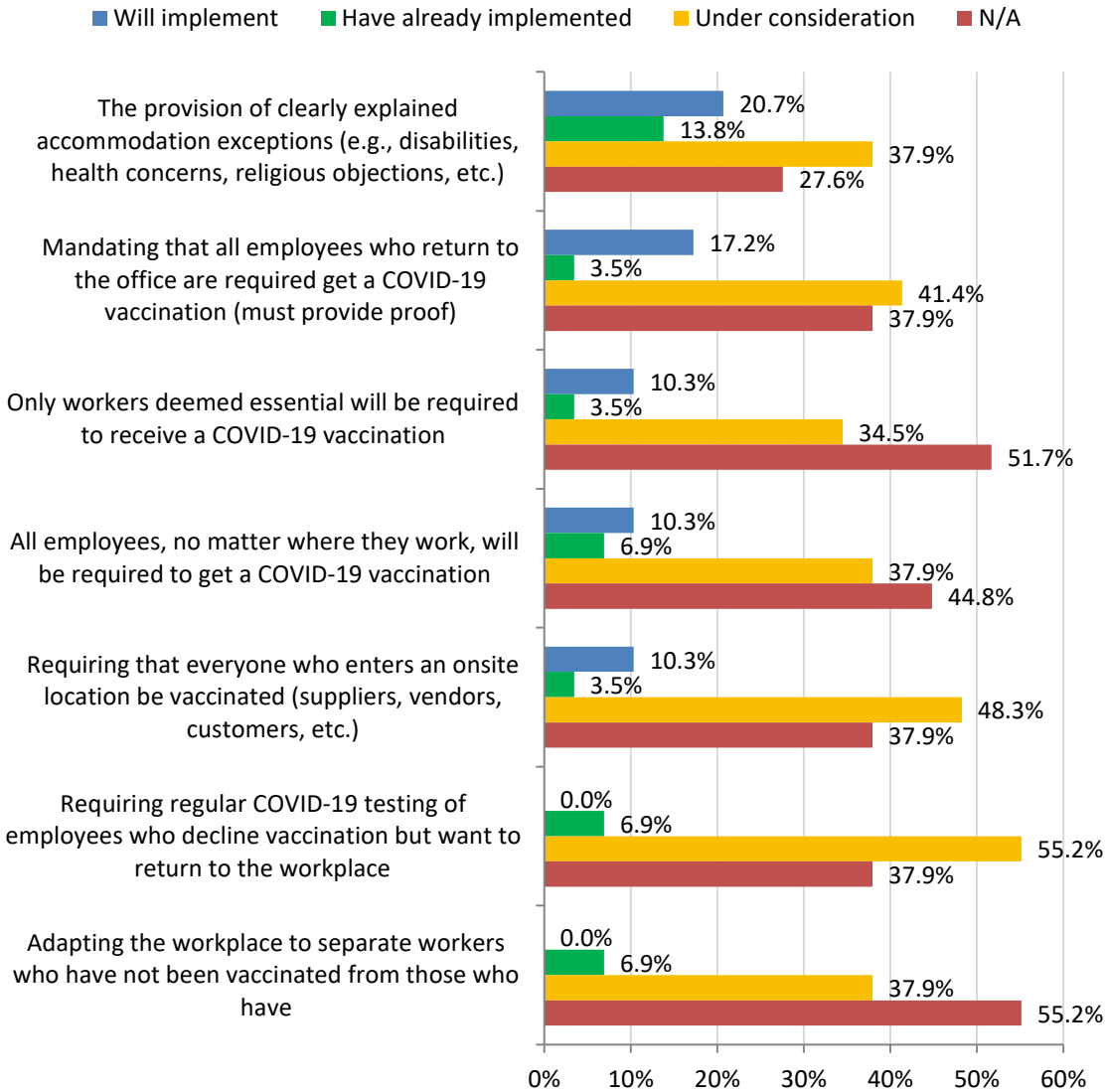

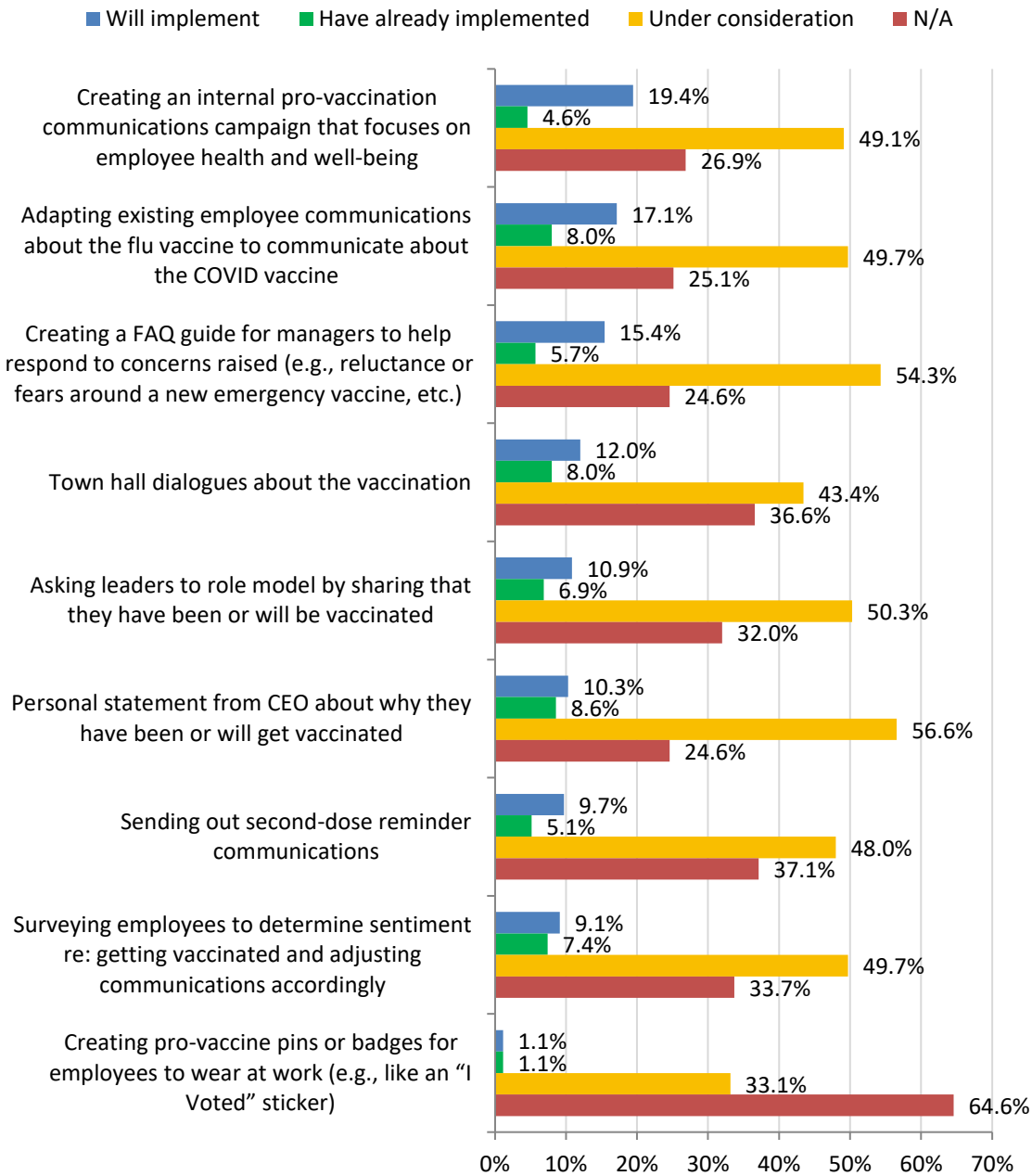

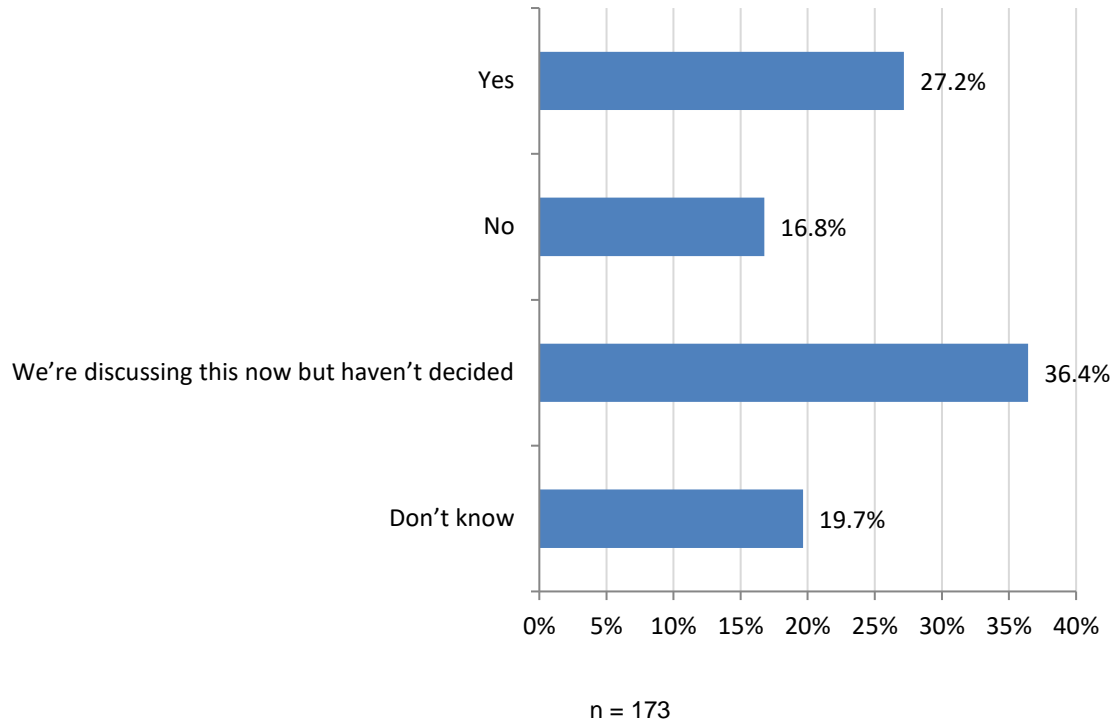
